This Statement on Schedule 13G is being filed by Dynamo Internacional Gestão de Recursos Ltda. (the "Reporting Person"). The Reporting Person serves as the investment manager of Dynamo Global Master Fundo de Investimento em Ações – Investimento no Exterior ("Dynamo Global Master Fund") and Dynamo Master Fund (together with Dynamo Global Master Fund, the "Master Funds"), which directly hold the ordinary shares reported herein (the "Ordinary Shares").
